

The Alternative Methods of Dispute Resolution Committee of the State Bar of New Mexico conducted and accomplished the following in 2023:

- 3. Continuing Education Presentations:


- a. The ADR Institute was held on 11/29/23. It was a full day of presentations.
 - i. Dathan Weems taught on the Mediation Procedures Act, titled,
 "The Mediation Procedures Act turns16. 1 General CLE
 - ii. Peter Merrill made a presentation on "Unique and Unusual Alternative Dispute Resolution Processes. 1 General CLE
 - iii. Mark Bennett Integrity in Action: The Structure and Practice of Ethics in Alternative Dispute Resolution. 1.5 Ethics CLE
 - iv. Panel 4 on the panel + the moderator. Ethical Neutrality-Managing Power Disparities in Alternative Dispute Resolution. 1.5 Ethics CLE
- b. There were approximately 51 attendees with the largest portion of them attorneys.
- c. The event was co-hosted by Tamara Couture and Rachel Donovan with an introduction of Raynard Struck the Chair of the NM Supreme Court Commission who spoke about the goal of the Supreme Court to get ADR options available throughout the state.
- 4. Committee Outreach/Initiatives/Events
 - a. The ADR Committee held 4 general membership meetings. Each meeting had a brief 15–20-minute business meeting and then a presentation to the attendees for the remaining 40-45 minutes.
 - b. Rachel Donovan is also the liaison for the NM State Bar and the NM Supreme Court so that the State Bar and the Supreme Court can collaborate to offer ADR options throughout the state.
 - c. We also had opportunities to present information to the new mediators taking classes with the UNM School of law giving them opportunities to become involved with the State Bar.
- 5. Scholarships
 - a. Not Applicable at this time.
- 6. Ongoing Section/Committee Items:
 - a. Forward moving plans for 2024 are for Lunch N Learns a few times throughout the year as well as another full day ADR Institute in November and the quarterly presentations during the general meetings. We have increased the number of people and groups receiving information for meetings and presentations.

2023 allowed us to build on the forward movement from 2022 when the committee was rebuilt after the Covid slowdown of programs and progress. We have increased those who attend both the steering committee and those attending the general meetings. We are grateful for the support we have received from the state bar staff in sending out

3. Continuing Education Presentations

- a. The Section conducted the 34th Annual Appellate Practice Institute on September 21, 2023. This full-day CLE program has been held annually on a continuous basis for a third of a century. Due to the COVID-19 pandemic, the 2023 API was the first time since 2019 that we were able to hold our signature CLE program in a combined live/virtual format. It is devoted to appellate practice issues and related ethics and professionalism matters. The keynote speaker was the Honorable Jeffrey S. Sutton, Chief Judge of the United States Court of Appeals for the Sixth Circuit. He is a nationally recognized scholar and jurist on state constitutional law, who presented remotely from his office at the University of Notre Dame Law School. New Mexico Supreme Court Chief Justice Shannon Bacon and Court of Appeals Chief Judge Jennifer Attrep also spoke, as did Justice Julie Vargas and the Chief Clerks of the New Mexico appellate courts. Dr. Amanda Parker, the State Bar's Equity in Justice Director, explained the activities and goals of that program.
- b. The Section joined forces with the New Mexico Supreme Court and the New Mexico Court of Appeals to hold our first Bench and Bar Conference since 2011 on October 20, 2023. This informal, half-day event was held in the Supreme Court Courtroom, followed by lunch. The format comprised less formal panel discussions, and the number of participants was limited to the capacity of the historic courtroom. Chief Justice Shannon Bacon offered prefatory remarks and participated in one of the panels, on extraordinary writs. The other panel topics included brief writing, oral argument, and miscellaneous issues of concern. In addition to the Chief Justice, the panelists included Justices David Thomson, Julie Vargas, and Briana Zamora, Chief Judge Jennifer Attrep and Judges Zachary Ives, Megan Duffy, and Jacqueline Medina, Chief Clerks Elizabeth Garcia and Mark Reynolds and Deputy Chief Clerk Lysette Romero Córdova, Supreme Court Chief Appellate Counsel Neil Bell, Court of Appeals Attorney Supervisor Cyndi Hernandez Madrid, Appellate Defender Kim Chavez Cook, and practitioners Tom Bird, Anne Kelly, and Caren Friedman.

4. Section Annual Meeting

a. The Section's Annual Meeting was held in person on September 21, 2023, during the Appellate Practice Institute, with the option for Section members to participate by telephone.

5. Section Outreach/Initiatives/Events

- a. The Section did not hold any Lunch and Learn meetings, a/k/a Brown Bag lunches, during 2023. These get-togethers with one or two appellate judges or justices over lunch were held in person at the State Bar Center before the COVID-19 pandemic, then shifted to a virtual format. While the Board considered reinstating these meetings in a mixed live/virtual format, we concluded that offering both the API and the Bench and Bar Conference in the fall brought many of the Justices and Judges in front of our Section members, and we did not want to make further demands on their time.
- b. The Section continues to support and promote the Volunteer Attorney Program's Appellate Pro Bono Program by encouraging Section members to participate. We also utilized the Section membership mailing list to assist the State Bar in seeking volunteers for New Mexico Youth and Government's moot court program and to help the New Mexico Supreme Court distribute its Order No. S-1-AO-2023-00023, In the Matter of Electronic Devices in the Supreme Court Building, to appellate attorneys on November 29, 2023.

6. Scholarships (if applicable)

- a. The Section offered partial stipends for the registration fee for the Appellate Practice Institute, but no requests were made for such financial assistance.
- b. In light of the State Bar's recently revised practice of allowing Sections to retain surpluses in their budgets, the Board opted to defer making a contribution to the Supreme Court's Judicial Clerkship program and potentially to the University of New Mexico Law School's moot court programs until 2024, after we assess the options and costs of bringing a paid keynote speaker to Albuquerque for the 2024 API.
- 7. Media (includes website and/or social media if applicable)
 - a. The Section did not prepare a newsletter this year and intends to update its webpage on the State Bar's website in early 2024.
- 8. Ongoing Section/Committee Items:


In 2024, the Appellate Practice Section intends to:

7. Media





2. Meetings

The ELLS Board held monthly meetings on the first Wednesday of the month from January through October and elected to forgo the meetings in November and December due to the conclusion of necessary activities.

The ELLS Board planned and hosted its annual Labor & Employment Law institute on September 15, 2023, which was offered both in-person and virtually. We had some great speakers, both new and veteran, who presented on a range of employment and labor law issues including: an update from the EEOC, with a focus on the Pregnant Workers Fairness Act, New Mexico's Healthy Workplaces Act, non-compete agreements, independent contractor issues, a labor law update, and ethical settlement and dispute resolution strategies.

The Section was also invited to present at the State Bar's Annual CLE event at the Tamaya in Summer 2023 and two ELLS members provided attendees an overview of a recent supreme court decision implicating the Fair Labor Standard Act provisions for overtime pay for certain workers.

4. Section/Committee Annual Meeting

The ELLS Board invited members to join the board, reviewed the group's financials, and discussed community outreach with the Young Lawyers Division and UNM School of Law.

In connection with the CLE, the ELLS Board hosted a kick-off "meet and greet" at Marble Brewery which was open to all Section Members who could mingle with the speakers of the annual CLE. 

4. Section Annual Meeting



2. Meetings

a. The ILS Board met a total of 7 times during 2023 starting in January, and on a bimonthly basis thereafter, with the exception of one supplementary meeting in February. Additionally, the ILS Board met on November 4, 2023, coinciding with the Indian Law Section Annual CLE for its Annual Meeting, open to the membership. ILS met quorum for all meetings.

3. Continuing Education Presentation(s)

 a. The 2023 CLE Committee consisted of four members of the ILS Board of Directors: Colleen Adams, Krista Thompson, Tom Peckham, and Sam Winder. In July, the CLE Committee successfully planned two breakout session CLE presentations at the State Bar's Annual Meeting. Professor Vanessa Racehorse of the University of New Mexico School of Law ("UNMSOL") presented on *Indian Law 101* and Judge Bruce Fox presented on *Practicing in Tribal Courts*. The CLE Committee also planned a successful 2023 Annual ILS CLE conference on Thursday, November 2, 2023. The Committee arranged for five panels with 12 speakers and want to thank Melody Delmar, Josett Monette, Darlene Gomez, Donna M. Connolly, Lindsay Cutler, Ellen Venegas, Sam Winder, Tom Peckham, Van Billops, Gwenellen Janov, Andrew DeLoris, Reed Bienvieu, and Denten Robinson for sharing their expertise with our section members.

4. Section/committee Mentorship

a. The Mentorship Committee met and discussed the existing mentorship opportunities with students at UNMSOL. Early in the year, the committee met with Rodina Cave Parnell of the American Indian Law Center, Inc. to discuss key ways the Committee could benefit students at the law school. The Committee has identified goals such as facilitating attorney-coaches for students before graduation, specifically to students in their first year of law school. The Committee plans on further discussing their goals with staff at the law school for the upcoming Spring 2024 semester.

5. Section/committee Outreach/Initiatives/Events

a. The Outreach Committee met intermittently throughout the year and scheduled several events to engage with membership and the legal community. The Committee sponsored two UNM NALSA events at Bow & Arrow Brewery in the spring and fall. The Committee also made sure to schedule or support member events held both in Albuquerque and Santa Fe throughout the year to increase networking opportunities: two were section-specific events held during the summer and fall. In addition to scheduling the section's mixers, the Committee planned the first ever joint social mixer with the New Mexico Hispanic Bar Association and sponsored the 1st Judicial District Bar Association's Holiday Party. The Outreach Committee was also happy to sponsor the reception celebrating the swearing in of attorneys planned by the Young Lawyers Division.

6. Scholarships

a. On May 12, 2023, the Scholarship Committee awarded bar preparation scholarships in the amount of \$500 to five 3L students at UNMSOL. These scholarships are intended to help defray the costs of preparing for and taking the New Mexico bar exam. In December 2023, the Scholarship Committee awarded Karl E. Johnson Memorial Scholarships in the amount of \$1,000 to three students at the UNMSOL. The Karl E. 8. Ongoing Section/Committee Items:



2. Meetings:

The IP Law Section holds monthly meetings on the fourth Tuesday of the month. In 2023, meetings were held by Zoom, except the Board met in person at the State Bar Center quarterly.

3. Continuing Education Presentation(s):

On September 25, 2023, the IP Section held its annual CLE day on the topic of Copyright and Artificial Intelligence. In order to accommodate and attract our section members and IP practitioners in the Santa Fe area and northern New Mexico, it was decided to hold the CLE in Santa Fe. Numerous issues caused disappointing attendance at the CLE, despite the high-quality speakers. The Board identified those issues as follows:

- The State Bar and MCLE's lack of assistance in promoting the event, which appears to be due to an unspoken State Bar policy not to assist with offsite events. Despite the CLE Coordinators' great efforts to get the State Bar's attention to promote the event, the State Bar ignored and/or delayed and stated such is "not something we do."
- The State Bar no longer identifies individuals in their communications with members, so it is impossible to determine who we are communicating with.
- Despite many efforts, the State Bar's only promotional support was a small note buried in the Bar Bulletin with an incorrect title that went uncorrected after numerous attempts.
- The Board feels that the State Bar penalized the IP Section for going to the trouble of an off-site event, or at the very least treated us like a nuisance.
- CLE Coordinators, presenters, and attendees had to have multiple communications with MCLE to ensure the correct CLE credits were given.

The IP Section has historically held an IP CLE annually. It is not clear if we will move forward with this in 2024 given the above experience. Several Board members, included the undersigned chair, reached out to various people, including the Bar Commissioner for Santa Fe, but got no meaningful responses to explain how poorly we, and our event, were treated.

4. Section/committee Annual Meeting

The Section held its annual meeting on December 1, 2023, at a local restaurant. Most of the Board and several section members attended.

5. Section/committee Outreach/Initiatives/Events

On October 31-November 4, 2023, the IP Law Section held its annual Fall Pro Bono IP Fair. This Fair included fifteen (15) registered clients, who were served by seven (7) attorney volunteers and shadowed by eight (8) law students from the University of New Mexico School of Law. While client registration was down this year from last year's 21 clients, additional marketing beyond what was historically done was not employed given that we had fewer attorneys available to volunteer. Law students reported great appreciation in attending consultations. The Board provided attorney volunteers a \$25 Starbucks gift certificate to show appreciation.

On Thursday, November 16, 2023, several Board members attended the UNM Law Lawyering Panel at the University of New Mexico School of Law. UNM Law School Lab students met with panels of attorneys to talk about their careers in (or out of) law after graduation. Each class had about 18 students, primarily 1Ls, who were in the early stages of developing their own professional identities. The goal with the panels was to give some additional context to their development through interactions with people besides their individual professors.

- 6. Scholarships (if applicable): The IP Section has not yet decided to move forward with scholarship opportunities, though the possibility is regularly discussed at Board Meetings.
- 7. Media (includes website and/or social media if applicable)

The IP Section was very active with its updates and announcements on its NM State Bar website and on the individual social media platforms of the Directors of the IP Section.

Additionally, The Board decided to initiate an IP Section LinkedIn account. We believe this would be a good way to connect with our members and other sections and provide a platform to post updates about the IP Section and possibly link to articles written by Section members. This effort will continue into 2024.

- 8. Ongoing Section/Committee Items:
 - Organize and conduct our annual Fall Pro Bono IP Fair in coordination with the UNMSOL and with the student-led IP Society at UNMSOL.
 - Reach out to NMSU with a possibility of organizing a Spring Pro Bono IP Fair, thereby serving entrepreneurs outside of Albuquerque and Santa Fe.
 - Continue to support UNMSOL students in fostering their interest in IP counseling and in IP careers.
 - Consider organizing another CLE day for the bar membership.
 - Coordinate and conduct an Annual Meeting of the IP Law Section.
 - Encourage Section members to participate in Bridge the Gap Mentorship Program.

Conclusion: The IP Law Section has continued to be an active group that is dedicated to supporting IP attorneys in the state of New Mexico, mentoring UNMSOL students, and providing pro bono legal advice for creatives, inventors, and businesses in New Mexico.




6. Scholarships (if applicable)



 - c. Probate Institute, November 16, 2023, full day, virtual program, 80 attendees


Honorariums for non-board speakers were provided to 4 in-state speakers (\$75) and 2 out-of-state speakers (\$125)

The following report outlines the SSFS activities and accomplishments in 2023.

 2023 Board of Directors: Charles Gurd (chair), Deian McBryde (chair-elect), Marissa Crowlett (secretary), Ian Bezpalko (budget officer), Rebecca Mulcahy, Brendan O'Reilly, Ashlea Crumley, Kymberleigh Dougherty, Gwen Shaw, Patrick Barry, and Erin Marshall.

Amara Aaron and Lucy River departed the board before the completion of their terms. The YLD Liaison resigned but that Division did not appoint a new liaison. However, the YLD did not appoint a new liaison.

2. **Meetings:** The section board held regular meetings throughout the year.

3. Continuing Education and Outreach:

"This year the SSF decided to forgo an all-day institute and focus on the "CLE round-tables" throughout the year. As many events and benefits tend to focus on the Albuquerque area, these round-tables were created with emphasis on providing access to these events to attorneys throughout New Mexico. As such, we held events in both Las Cruces and Taos, which included social events with attorneys and judges, and collaboration with other sections, such as the Family Law Section for the Taos roundtable. We can attribute much of our Board's success in managing these events through our efforts in previous years to ensure a diversified Board for representation throughout New Mexico. The SSF Section also hosted a CLE in Albuquerque for the mandatory trust accounting credit, which was well attended and the Section was able to provide this CLE at no cost for its attending members.

Section Annual Meeting: Tuesday, December 19, 2023, 9:00 a.m.

5. Fellowships:

a. The section awarded a 2023 fellowship to James Owens that included paid registration to the 2023 Annual Meeting. The section may continue to grow this opportunity.

6. Media:

- SSF maintains a Facebook group for members that remained largely inactive except for occasional posts of events made by the chair-elect.
- b. The section's listsery remains active, although the "mailing list" functionality provided by the Bar is antiquated and inadequate. Nevertheless, members use the list to request support and referrals from one another, although they also continue to ask about more modern and effective technology.

7. Ongoing Section Items:

a. The SSFS continues to work with other Sections, Divisions, and Committees. For example, at the request of SSFS member, Laura Johnson, the Chair requested an eblast be sent to SSFS members about a Family Leave Project developed by the Committee on Women in the Legal Profession.

The SSFS contributed to the YLD's Swearing in Reception that was held on October 12, 2023. Three Board members attended the Reception: Deian McBryde spoke on behalf of the Section and Erin Marshall and Charles Gurd spoke with recently admitted attorneys.

Representatives from the SSFS – Deian McBryde and Erin Marshall – spoke with law students on October 17, 2023.

b. The section continues to support solo and small firm attorneys to comply with the new mandatory succession planning rules in close cooperation with William Slease.

KEY PLANS FOR 2024:

Deian McBryde, our current Chair, previously had a motto, "Lawyers Serving Lawyers." As Chair, I continued that Moto. I believe that in 2024, Deian McBryde will continue that Moto. Deian has stated: "Being solo shouldn't mean feeling alone." I hope we have made an impact here, too. The larger issues of attorney loneliness, business anxiety and development, and personal and financial well-being are ones that our Bar should embrace more fully. We should not leave any members feeling as though they are alone.

Specific Focus:

- In 2024 under the excellent leadership of Deian McBryde, the SSFS will continue to work with various Sections, Divisions, and other Bar and non Bar legal organizations.
- Furthermore, because the vast majority of New Mexico attorneys are solo and small firm attorneys the SSFS is planning to conduct Round-table CLE programs from around the State. It is the goal of the SSFS to be able to listen to, assist, and work with as many solo and small firm attorneys as possible.
- While the Board paid for one Fellow to attend the 2023 Annual Meeting, the Board is contemplating the
 possibility of paying for more fellows or it may create a Fellowship program so that the individual can attend one
 of the ABA conferences.
- Early in the year, the Board will decide whether to do a half day or full day CLE Institute.
- The SSFS Board will continue to work on a system that will allow it to communicate better with its members.

CONCLUSION:

Although in 2023, the SSFS continued to work with its members and continued to do projects to help solo and small firm attorneys I strongly believe that in 2024, the Section will do even more – especially since the vast majority of attorneys licensed in New Mexico are solo attorneys or work in a small practice.

2. Meetings

- January December: The Section held regular meetings monthly, on the second Tuesday of each month. Meetings were held via Zoom and quorums were met for each meeting.
- b. **December:** The Annual Meeting of the Membership was held in conjunction with the Tax Symposium on December 13, 2023 (see below).
- 3. Continuing Education Presentation
 - a. **General:** Building on the momentum from 2022, the Tax Section, together with the New Mexico Society of CPAs, held an annual Joint Tax Symposium on December 13, 2023 with speakers from both the legal and CPA communities. The day-long program

- qualified for 6.3 general CLE credits and 1.0 hour of ethics, as well as CPE accreditation for the attending CPAs. The Symposium was held at the State Bar Facility, but could also be attended remotely. To defray costs, the Tax Section and the NMSCPA each obtained two sponsors for the event.
- b. Curriculum: The agenda for the event is accessible through the State Bar. It included updates from the New Mexico Taxation & Revenue Department, New Mexico Legislative Updates, Federal Tax Legislation Updates, as well as presentations on artificial intelligence in tax practice, issues in partnership mergers, hot topics in tax compliance, and an ethics presentation on concurrent conflicts of interest.
- c. **Participation and Attendance:** 72 State Bar attendees participated in the Tax Symposium, with 19 attending in-person and 53 attending virtually, including 4 YLD members sponsored by YLD. 77 CPAs registered for the Tax Symposium, with 42 participating in-person and 34 attending virtually (35 were registered).
- 4. Section/committee Annual Meeting
 - a. The Section's annual meeting of the membership was held in conjunction with the Tax Symposium on December 13, 2023. Topics discussed included:
 - i. January 2024 follow-up to Tax Symposium;
 - ii. Ways to improve Tax Symposium in 2024;
 - iii. Ways to improve outreach in 2024.
- 5. Section/committee Outreach/Initiatives/Events
 - a. Informal outreach and networking between attorneys and CPAs at the annual Tax Symposium.
 - b. The Section and NMSCPA conducted a lunch meet and greet with Dee Wald, the new Chief Counsel for the New Mexico Taxation & Revenue Department, on September 22, 2023 in Santa Fe. This event gave Tax & Rev's new Chief Counsel and approximately 15 attorney and CPA practitioners the opportunity to interact socially and informally.
 - c. Facilitated by its UNM Student Liaison, the Tax Section conducted a Tax Lawyer Career Day at UNM Law School on March 30, 2023. The Tax Section provided lunch and the event was well-attended, with approximately 25-30 students attending.
- 6. Scholarships and Donations
 - a. The Tax Section sponsored the Hugh Muir Scholarship award, which UNM presents to the outstanding tax student in its graduating class. The recipient is chosen by UNM Law School faculty and the award is presented at the graduation ceremony. The Section funded the award in December of 2023, for presentation in May of 2024.
 - b. The Tax Section also made a \$500 award to New Mexico Legal Aid, Low Income Taxpayer Clinic to assist with system upgrades.
 - c. The Tax Section donated \$300 to the Young Lawyers Division to assist in sponsoring a reception for newly admitted lawyers.
- 7. Media
 - a. The Tax Section maintains a website through the State Bar.
- 8. Ongoing Section/Committee Items:



The Well-Being Committee (WBC) was created at the end of 2019, prior to the beginning of the Covid 19 Pandemic, in an effort to encourage health and well-being among New Mexico lawyers. This committee was also created with the intention of following the steps laid out by the National Task Force on Lawyer Well-Being. The NM Well-Being Committee is comprised of stakeholders from the bar, regulation, the law school, the Judiciary, and the paralegal community. All of its members are from around the state and have an interest in legal well-being.

Four subcommittees met regularly through the first half of 2023 to work on different aspects of well-being programming: Strategic Planning, Events/CLE, Yearly Campaign, and Judicial Wellness. There was a re-organization of sub-committees toward the mid/end of 2023 and is detailed below. The subcommittees met as needed between the larger Well-Being Committee meeting which met every other month.

The Well Being Committee conducted and accomplished the following in 2023:

- 1. Board of Directors
 - a. The Well Being Committee does not have a Board of Directors.
- 2. Meetings
 - a. Meetings were held every other month.
 - i. Jan. 31, March 28, May 30, July 25, September 26, and November 28, 2023.
- 3. Continuing Education Presentation(s)
 - a. No CLE presentations conducted by WBC in 2023.
- 4. Section/committee Annual Meeting

- a. The WBC had a brainstorming retreat on Tuesday, Aug. 8, to discuss and come to agreement on a 3-5 year plan for goals/projects/initiatives. See attached document for results of the retreat.
- b. The WBC reorganized its sub-committees eliminating the Strategic Planning Sub-Committee and agreeing to move that work into the larger committee. The CLE/Events Sub-Committee was combined with the Yearly Campaign Sub-Committee. At the end of 2023, the WBC has two working sub-committees the Yearly Campaign Sub-Committee and the Judicial Wellness Sub-Committee.
- 5. Section/Committee Outreach/Initiatives/Events
 - a. The WBC co-sponsored a Pumpkin Run/Walk event in October paying \$500. Other co-sponsors were the Lawyer's Assistance Program (LAP) and the Young Lawyer's Division (YLD). The event yielded a total of 40 participants signing up under the WBC. The participant breakdown is as follows: 30 participants for the 5K/10K: \$900, 3 participants for Youth 5K: \$54, and 7 participants for Kids 1K: \$105.
 - b. The Strategic Planning Sub-Committee of the WBC presented on three different occasions in Professor Natalie Martin's class at the UNM School of Law. Presenters were Sean Fitzpatrick, Dr. Amanda Parker, and Bill Slease. Topics were varied, but centered around how to maintain or increase well-being while being a practicing attorney.
 - c. The Yearly Campaign Sub-Committee continued to plan, record and publicize monthly podcasts and accompanying articles under the 2023 Campaign title of A Deeper Dive. Some of our highlighting presenters and authors were: Dr. Evelyn Sandeen, Elizabeth Lynch Phillips, William Slease, Brian Nichols, Sean Fitzpatrick, Aja Brooks, Alexander Uballez, United States Attorney for New Mexico, Dr. Amanda Parker, and Judith Gordon, UCLA School of Law faculty....to name a few.
 - d. The Judicial Wellness Sub-Committee also planned, recorded and published two podcasts on the following topics – Resiliency for Judges with speakers Hon. Sandra Engel (ret.), Hon. Senior Justice Barbara Vigil (ret.), Hon. Shammara Henderson, and Hon. Brett Loveless; and (2nd topic) Resources and Services for NM Judges with speakers Pam Moore, Hon. Justice David Thomson, Hon. Shammara Henderson, and Hon. David Murphy.
 - e. The WBC was present at the Annual Meeting by offering swag in the form of fidget spinners and inviting attendees to write down and post what they are thankful for on a Gratitude Board. This was a fun and popular item on Friday, July 28, 2023.

WBC STRATEGIC PLANNING BRAINSTORMING SESSION

The WBC Strategic Planning Subcommittee met on August 8, 2023, and recommends that the WBC adopt a two-tiered strategic plan for the next 3 to 5 years, beginning January 1, 2024. The two identified tiers are:

Tier I - Education, Awareness and Activities

Tier II - Advocacy and Community Support and Engagement

The Subcommittee recommends dissolving the current subcommittees and reforming two working groups to develop and work on well-being programs and initiatives within the above-two tiers.

The group then identified the following goals and action items:

1. **Goal** - Work with the UNM School of Law to support integration of well-being into the curricula on a sustained basis.

Action item – invite UNM Faculty member to join WBC.

- Meet with the Dean to discuss this.
- 2. **Goal** Increase WBC engagement with law firms, including lawyers, paralegals, and support staff.

Action items – develop well-being toolkits for solo and small firms.

- target firm leadership for well-being initiatives
- Do we add Judicial wellness as a bucket?
- 3. **Goal** Examine and possibly advocate for rule changes that promote well-being.

Action items - work with Bridge-the-Gap to include well-being in mandatory curricula

- consider MCLE change
- consider commentary change for Rules of Professional Conduct (similar to ABA suggestion - competence includes well-being)
- 4. **Goal** Continue to develop and deliver effective CLEs and activities for the legal community.

Action items - develop sustained well-being curricula.

- target law firm leadership for well-being initiatives and offerings
- Look at how our CLE content is delivered and structured
- -What content is useful/ not useful
- 5. **Goal** Develop well-being programs that address and are tailored to different career stages.
 - -New lawyers might need different benefits and well-being programs than retiring lawyers
 - -How do we determine what those programs are?
- 6. **Goal** Determine how to incentivize well-being.

Action items - coordinate with State Bar Members Services to determine if it is possible to offer well-being incentives or benefits, including things like a discounted gym memberships, yoga classes, etc.

- target law firm leadership for well-being initiatives and offerings
- Wellbeing discounts: Define fitness, yoga
- 7. **Goal** Develop metrics to determine progress/success.
 - Sending out a survey- as needed to members of the committee to check on progress and or success
